

Privacy Policy

The Gmeinder Getriebe- und Maschinenfabrik GmbH appreciates your visit to our website and your interest in our company and our products. The protection of your personal data is very important to us, when collecting, processing and using it during your visit to our website. Please find below detailed information on what data we collect and use during your visit.

Collected Data

Personal data is information that can be used explicitly to determine your identity. This includes information such as

- your real name,
- E-Mail address,
- postal address,
- phone number, etc.

Anonymous log data is information that is not directly linked to your real identity. This is for example, the number of users of a website. This data is not in the category of personal data.

Generally, no personal data is collected when you visit the website of the Gmeinder Getriebe- und Maschinenfabrik GmbH. By default the web server stores

- the operating system,
- the type of browser,
- the website from which you visit us,
- the pages you visit with us and
- the date of your visit.

This information can be used for statistical purposes to improve our website and our service. The data cannot be assigned to a specific person. The data is not merged with other data sources.

Collecting and Processing Personal Data

Personal data is only stored if you provide it explicitly. For example, if you request information or contact our complaints management, your personal information will only be passed if it is for the purpose of the contract or required for accounting purposes. This is in accordance with § 11 of the federal data protection law, commissioned data processing, or with your consent. Your personal data will not be sold to third parties.

A transfer to authorized governmental authorities takes place only in the context of mandatory law or when we are obliged by court order.

Purpose of Processing

The data we collect will be used only to provide you with the requested products or services, or for other purposes for which you have given your consent, if there are no other legal obligations. Our employees are obliged by us to maintain secrecy in accordance with the federal data protection law.

Storing Data

The Gmeinder Getriebe- und Maschinenfabrik GmbH stores personal data as long as it is necessary to perform a service that you requested or to which you granted your consent, if there are no other legal obligations.

Right to Withdraw

You can revoke your consent to the use of personal data in whole or in part at any time with future effect.

Security

The Gmeinder Getriebe- und Maschinenfabrik GmbH uses technical and organizational measures to protect your data against accidental or intentional manipulation, loss, destruction or unauthorized access. Our security measures are improved continuously in accordance with the technical development.

Children

Personal information from anyone under the age of 18 should not be submitted to our website without the consent of a parent or guardian. The Gmeinder Getriebe- und Maschinenfabrik GmbH strongly encourages all parents and guardians to give their children an introduction to the safe and responsible handling of personal data on the Internet. We will not knowingly collect, process and use personal data from children.
